Location and Facility

Asheville, the "Land of the Sky," is located in the Blue Ridge Mountains and is the largest city in Western North Carolina. Asheville is known as one of the "Best Places to Reinvent Your Life" (AARP Magazine, 2003) "Top Seven Places to Live in the U.S." (Frommer's, 2007), and one of the "25 Best Places for Business and Careers" (Forbes, 2012). WNCSOM students find inspiration and support in Asheville, a community steeped in the tradition of the healing arts. Those pursuing the fullest potential of their massage and bodywork education could not ask for a better location.

Our facility is easy to find and is located in the heart of West Asheville. The spacious, light-filled main classroom at 707 Haywood Rd #001 Asheville, NC accomodates 20 students plus teacher comfortably, while our student lab and luxurious private treatment rooms are perfect for practicing vour student clinical sessions. The school is well equipped for the learning process with adjustable massage tables, massage chairs, anatomy charts, audiovisual equipment and skeletal models. In the library, students can access a wide selection of books, periodicals and DVDs on massage therapy and other health-related subjects. There is ample free parking on the street as well as a paid monthly parking lot within easy walking distance.



Educational Program Objectives

The 625-hour Massage Therapy Diploma Program offers a comprehensive education, preparing students for productive careers in massage and bodywork. Students will:

- Utilize efficient body mechanics to perform techniques with ease and benefit of clients.
- Apply with increasing confidence, relaxation and deep tissue massage techniques.
- List the structures and functions of the human body and the benefits of massage for each system.
- Practice the dynamics of a professional therapist/client relationship.
- Design personal career goals and apply business and marketing skills to create a successful career.
- Demonstrate ethical and professional conduct as a massage therapist.
- Use assessment protocols to create customized therapeutic sessions.
- Utilize self-care techniques.
- Build relationships with other healthcare providers in your community.

Massage Therapy Diploma Program Overview

All full-time, part-time, day and evening, massage therapy diploma programs offer 625 hours of well-crafted massage training. This program conveys a coherent, congruent sense of the body and the massage process. By gradually building on the skills gained in each core bodywork course, with anatomy and physiology paralleling the entire process, students build a strong experiential core of massage approaches integrated with a working



knowledge of the body's systems. An over-arching emphasis is placed on students developing a deeper presence and awareness surrounding their touch, helping them to develop sensitivity and make this an integrated part of their practice.

Since it is natural to develop self-knowledge through this educational process, we also provide courses that guide the translation of knowledge into professional skills for the massage practitioner. Such courses are woven throughout the program and include Professional Ethics, Somatic Psychology, Business and Marketing Practices. By the time students pass the core Therapeutic Relaxation Massage course, they are ready to offer full-body massages to the public during their student clinical internship. This clinical experience gives students valuable professional experience in a safe and supervised environment. It is here that we watch students blossom into competent therapists and their confidence soar. From the lightest compassionate touch to the deepest musculoskeletal tissues, students are able to demonstrate a "holistic" approach to bodywork in their own unique, creative style.

Massage Therapy Diploma Program

The program is comprised of 625 clock hours, with a clock hour defined as at least 50 minutes of any one clock hour during which the student participates in a learning activity in the physical presence of a member of the school's instructional staff.

Bodywork Classes

WNCSOM students are trained in several core modalities that are commonly requested by both clients and employers.

Introduction to Massage Therapy 25 hours

In this introductory component, students will be introduced to the foundational principles of massage therapy to prepare them for their educational journey. They will explore the power of touch as a therapeutic method and discuss the importance of professionalism in practice. They will be introduced to basic massage techniques, draping protocols, and safety and hygiene standards. They will explore safe movements and proper body mechanics to protect them in their educational and professional practice. They will also be introduced to medical, directional, and movement terminology that will prepare them for their anatomy and kinesiology coursework.

Therapeutic Relaxation Massage 100 hours

Students learn about the history and evolution of the massage profession. By the end of this course, students will be able to give and receive a full body massage in this unique and refined training. This course has been developed from over 20,000 hours of combined

practice of talented massage therapists including Hope DeVall and their esteemed teachers, utilizing proper body mechanics and an emphasis on forearm, open fist, open palm and knuckle techniques. Simultaneously, students are trained in the qualities of a sensitive, mindful touch and compassion to powerfully awaken and enhance the therapeutic process. Through breathing exercises in heightened awareness and mindfulness, and performing blind-folded massage, students consciously develop their

abilities and bring them more fully into their bodywork. Professional communication and developing the ability to manage and meet a client's goals also form an integral part of professional development at this phase of the curriculum.



Neuromuscular Therapy 100 hours

Neuromuscular therapy (NMT) is a comprehensive and advanced system of soft tissue manipulation that specializes in working with chronic muscle pain. On the basis of neurological laws, this therapy works toward bringing the body's central nervous system into homeostatic balance with the musculoskeletal system using various Swedish massage strokes, such as linear effleurage, deep friction, along with trigger point release and myofascial release. NMT techniques, along with a thorough structural evaluation, are needed to understand and treat the causative factors involved in acute and chronic muscle pain and dysfunction. Specifically, NMT is used to deactivate trigger points in muscles. It is also used to lengthen chronically shortened muscles and balance muscle groups, especially when working with people suffering from postural



dysfunction. It is used to treat chronic pain stemming from various injuries, such as those related to sports injuries (strains), car injuries (whiplash), repetitive strain injuries (carpal tunnel syndrome), accumulative trauma injuries (TMJ dysfunction) and skeletal problems (disc herniation). Being trained in this therapy will allow a massage therapist to specialize in working with chronic muscle pain and take an active role in helping people overcome injuries and postural dysfunction.

Energy Theory (Reiki Level 1) 10 hours

The WNCSOM supports the "holistic" view of healthcare; mind, body and spirit. Energy work is an intention-based form of therapy that uses simple hands-on, no-touch, and visualization techniques, with the goal of improving the flow of a person's electromagnetic fields to relieve stress and pain, and to improve the symptoms of various health conditions. In this course we explore some of the concepts from TCM & Ayurvedic Medicine and how those philosophies influence the art of massage therapy.

Sciences

The sciences explore the intricate workings of the structure and function of the human body and how it performs life processes in health and disease. These subjects are approached with curiosity and in the spirit of learning a new language.

Musculoskeletal Anatomy & Kineseology 100 hours

This course is the heart of the program. Utilizing the critically acclaimed textbook/ workbook, Trailguide to the Body, students palpate all the major muscles of the body as well as their bony attachments. In class, students identify muscles along with their action and attachments through the workbook exercises, cadaver videos, palpation direction videos, creation of muscles in clay and drawing the muscles on classmates. Palpating the muscles on all their classmates of varying body-types increases proficiency in the skill most sought after in any massage therapist. Communication skills are also developed to ensure the depth of touch is of a therapeutic nature.

Anatomy and Physiology, Pathology

100 hours

This course explores the structure and function of the body's major systems and how disease occurs in the body, common pathologies and the symptoms often exhibited by a person. Through one of the most recognized textbooks in the profession, Massage Therapy Principles and Practices, students discover how the body operates and explore the benefits of massage on each system. Students learn to develop critical thinking skills in understanding when massage is indicated or contraindicated for different pathologies that may be encountered in a massage practice. Presentation of the material is by lecture, discussion, audio-visual aides and various adult teaching strategies to ensure comprehension and familiarity with medical terminology. Through the use of visual aids, discussion of case studies and designing a treatment protocol, students develop the ability to make appropriate decisions regarding a client's treatment needs.

CPR / First Aid / AED

WNCSOM offers students and graduates a two-year certification through the American Heart Association.

Professional Development

Our courses in Somatic Psychology, Business Practices, and Professional Ethics, contribute to increased awareness of self and how we relate with others. Personal growth is a natural component of the program as students learn more about themselves, and come to understand the importance of self-reflection in the process of becoming a massage therapist.



Somatic Psychology

45 hours

Somatic Psychology course enables the student to develop their interpersonal communication skills to establish and maintain healthy client/therapist relationships. This course encourages students to explore their beliefs, values and attitudes about such topics as touch, sexuality, intimacy, and money. Students will explain the issues about boundaries,

safety, transference and emotional release and devise strategies to cultivate compassion and awareness within ourselves and others.

Business Practices

30 hours

Students learn to develop innovative strategies to achieve a fulfilling career in a variety of areas including private practice, spas, and other massage venues. Topics include working with budgets, marketing, sales and client retention. Students prepare short term post-graduate career goals, design and implement practical activities to bring their dream into reality.

Professional Ethics

15 hours

Students will determine what constitutes ethical behavior and implement strategies for solving ethical dilemmas. This course also focuses on the NC laws and rules and prepares the student toward applying for the massage licensure exam as well as navigating through the licensure process.

Research Literacy - Case Report Project

Because the use of research based evidence in clinical decision-making is a core skill for all health care professionals, it is important that massage therapy students learn to think critically and evaluate research as part of their entry level massage education. In an effort to provide students with the tools needed to bridge the gap between research and clinical practice, this course component offers an introduction to research that empowers students to actively engage and participate in research via the creation of a case study project. At the end of

this course, the students will have the opportunity to submit their case reports to the Massage Therapy Foundation, student case report contest. This course component provides the students with a foundation of research knowledge, a compilation of resources, and project-based participation intended to set the groundwork for evidence-based practice.

Supervised Clinical Practice 100 hours

Students begin their clinical internship where they apply their knowledge in practice within a "real-world" massage environment with the guidance of clinical supervision. Here, students have the opportunity to engage with the public, offering massage therapy, while demonstrating, knowledge and skill. Students receive feedback from clients and clinical supervisors to foster their growth and professional development. This supervised clinical provides students with a solid foundation upon which to build competency and a successful, gratifying career.

NC State Rule .0626 STUDENT COMPENSATION PROHIBITED

A student shall not receive a fee, tip or other consideration for the massage and bodywork therapy they perform while completing clinical requirements for graduation, whether or not the school charges a fee for services provided in a student clinic.

Hope DeVall is the founder, program director, and lead instructor for the Western North Carolina School of Massage. Hope began her career in holistic health in 2006 while she was living abroad in the Dominican Republic. While there, she transitioned from a fast-paced corporate career in the furniture/interior design industry to a more mindful career in healing arts, studying and practicing herbalism, aromatherapy, reiki, and yoga, in addition to therapeutic massage. GRADUATION AND LICENSURE REQUIREMENTS

WNCSOM will grant a diploma to those students who satisfactorily fulfill all attendance requirements, complete all course requirements with passing grades, and comply with all WNCSOM policies as outlined in the student handbook.

In NC, licensure is a legal requirement. Licensure information can be obtained by the NC State Massage Board. To become a North Carolina Licensed Massage and Bodywork Therapist, you are required to graduate from a Board-approved school, and pass the Massage and Bodywork Licensing Examination (MBLEx).



Massage Therapy Diploma Program:

The full-time and Part-time Day massage therapy Diploma Programs begin every 12 weeks. The Full-time Day Program lasts 25 weeks (approximately 6 months). The Full-time Day program lasts six months and is held Monday-Friday from 9am -2:30pm. The Part-time Day program is held Monday - Wednesday 9am - 2:30 pm for the first six months and shifts to Thursday and Friday from 9am - 2:30pm for the remaining six months. The Part-time Evening program lasts one year beginning each February, and is held Monday, Wednesday and Thursday from 5pm -9:30pm. We offer four weeks of vacation throughout the year. One week during the summer, the week of Thanksgiving, and the two weeks of Christmas and New Years

A \$300 discount is offered to those students who pay the full tuition 30 days before the first day of class.



WNCSOM students will be eligible for discounted equipment and supplies through Massage Warehouse as part of their free AMTA Student Membership.

In House Payment Plan Option

WNCSOM offers an affordable payment plan for those who qualify. Once you pay the initial tuition deposit of \$750, along with the costs of textbooks & supplies, the balance of \$7,245 can be paid over a period of 27 monthly payments at an affordable \$295 per month at 9.9% interest.

Refund Policy

Students may cancel within 72 hours of signing the enrollment agreement and receive a full refund. Students who withdraw before the program start date will receive a full tuition refund less the tuition deposit.

Students who withdraw after starting the program are entitled to a refund based on the percentage of the program they have completed, up to completing 25% of the program. Students who withdraw after completing 25% of the program are not entitled to a refund.

Students who are dismissed are not eligible for a refund.

A full refund will be granted in the event of a program cancellation.

Admissions Policy

Admission to the Massage Therapy Diploma Program is entirely at the discretion of the school. Class size is limited to 16 students in order to maximize the quality of training, personal attention and support for each students growth and development.

Entrance Requirements

During the application process, we support students in assessing their ability to make the personal and financial commitment to this new career and lifestyle. Our expectations of the students is that they will bring their deepest presence and commitment to learning and personal growth. The nature of our program requires that they be willing to work responsibly with us in creating a cooperative, dynamic learning environment.

All applicants shall:

- Be at least 18 years old and have a high school diploma or G.E.D.
- Be able to make the commitments necessary to complete all course requirements, both in-class and out-of-class.
- Be willing and able to uphold the ethical standards of the school and of the massage therapy profession.
- Have the means to uphold their financial agreements.
- Provide one personal and one professional reference.
- Write an essay, answering the seven questions listed on the application.
- Attend an interview.

- Read and sign the Enrollment Agreement.
- Complete all requirements of the admissions process including signing the Enrollment Agreement.

Once you have decided which program to attend, fill out the attached application form and send the necessary information to our admissions department. Upon receipt of your application, we will review it and then schedule an interview with you. If you are accepted, you will complete the enrollment process by signing the enrollment contract and paying the \$750 non-refundable deposit. You are on your way to becoming a massage and bodywork therapist!

Satisfactory Progress Standards

Students must maintain a passing GPA of 70% or higher in all courses at all times. If a student fails a quiz or test they may re-take the quiz/test/practical once. A student is allowed to re-take no more than 3 failed guizzes, tests or practicals their entire program.

Grading System

The following grade indicators are used to measure academic performance.

P=Pass F=Fail I=Incomplete
A grade of 70% or higher is considered passing. A student must pass all course components in order to receive their diploma.

Attendance Requirements

For a student to receive credit in a course, the student shall attend no less than 75 percent of the instructional hours of the course. The student shall also make up sufficient missed instructional hours to equal no less than 98 percent of the instructional hours in the course according to the procedures established by the school. If a student is absent on an assessment day, they must take any missed quizzes, tests or practicals within 14 days of the original

test date. If a student is absent complete make-up work contract and any assignments listed and email your answers which are due 14 days from absence. If a student misses a class with a practical component, an additional clinical hour is due for each lab hour missed. It is the student's responsibility to keep up with any missed assignments or makeup work. An A progress report will evaluate attendance hours every 13 weeks

Tardiness Policy

Punctuality is a requirement of success in any professional endeavor. A student who arrives 5 minutes or more after class has begun is tardy. The third tardy is considered an absence for that day and makeup work is required. The 3rd tardy will also result in a written warning notice. A student who arrives 15 minutes or more after class has begun is considered absent for that day and makeup work is required for that day. These same rules also apply for leaving early.

Make-up Work Policy

The student is responsible for completing any missed class assignments. If a student is absent on an assessment day, they must take any missed quizzes, tests or practicals within 14 days of original test date. If a student is absent a make-up work contract will be emailed to you along with the makeup work requirements. The student is responsible for completing any assignments due and will email your makeup work to info@wncmassageschool.com within 14 days of the absence. If a student misses a class with a practical component, an additional clinical hour is due for each lab hour missed. A student may choose to make up this time with either a prescheduled clinical massage (we will schedule the client for you) OR an hour of private tutoring. The cost for private tutoring is \$40 per hour paid directly to the instructor.

Standards of Conduct

Students are expected to have ethical behavior and integrity. Students may be warned, placed on probation indefinitely, or dismissed from the program for violations that include but are not limited to:

- Failure to adhere to the NCBTMB Code of Ethics and Standards of Practice (see attached)
- Unsatisfactory academics or attendance
- Attending class under the influence of drugs or alcohol
- Engaging in cheating or plagiarism Failure to maintain appropriate hygiene
- Noncompliance of the Dress Code
- Accepting any form of compensation for massage services provided as a student (this includes barter or gratuities)
- Engaging in sexual harassment of students, faculty, staff or clinical clients
- Participation in sexual activity or sexual advances on school property
- Physical or verbal abuse to anyone
- Failure to disclose health conditions that are detrimental to you or classmates
- Theft or damage to the school's or another student's property
- Failure to maintain up to date financial payments
- Harming a student or clinical client by means of abuse or neglect
- Sharing information from a fellow student or clinical client that was disclosed in confidence.
- Disruption of the classroom
- Direct insubordination of an instructor

Important Note: The Western Noth Carolina School of Massage reserves the right to amend or add school policies as its sees fit, and address other concerns not listed on a case-by-case basis.

Disciplinary Procedures

A written warning will be issued to the student stating the specific noncompliance of school requirements in policies, procedures, or conduct.

Probation Conditions

Continued noncompliance after a written warning results in probation. A student placed on probation may continue in the program on a conditional basis. The length and conditions of the probation are at the discretion of the Program Director.

Dismissal Conditions

If a student fails to meet the terms and conditions of probation, the student will be dismissed. Note: Some behaviors that directly violate the code of ethics may result in

immediate dismissal from the program. Reentry Conditions for Dismissal for Unsatisfactory Progress After dismissal a student may reapply for entry into the next available program. If the student chooses to reapply and is accepted, the student will be notified of the course and financial requirements at that time. The readmission to the program will be decided at the sole discretion of the Program Director on a case-by-case basis.

Transfer of Credit from Other Institutions

Western North Carolina School of Massage does not accept credit from any other institutions.

Leave of Absence Policy

A student must request, in writing, a leave of absence is they will be absent for more than 14 consecutive days of the program. A leave of absence may be granted only at the discretion of the Program Director. A leave of absence may be granted for no more than two week. Financial obligations are still due. Upon return, the student has 14 days to take all missed quizzes, tests and/or practical evaluations.

Complaint Process

The student should first attempt to resolve the situation with the fellow student, instructor or staff member with whom the alleged problem originated. An attempt should be made to resolve the matter at this level. If the grievance is not resolved, the student may file a written grievance with the school and made available to the Program Director. The Program Director shall respond to the student within seven (7) working days of receipt of the grievance form. If the decision of the Executive Director does not satisfy the grievant, the concerns should be directed to the NC Board of Massage & Bodywork Therapy at P.O. Box 2539, Raleigh, NC 27602.

.0626 STUDENT COMPENSATION PROHIBITED

According the NC state regulations, it is unlawful for a student to receive compensation for massage in any form. Section .0626 of the NC practice act states that a student shall not receive a fee, tip or other consideration for the massage and bodywork therapy they perform while completing clinical requirements for graduation, whether or not the school charges a fee for services provided in a student clinic.

Criminal History Record Checks

Pursuant to NCSG 90-629.1, the NC Board of Massage and Bodywork Therapy may deny a license to practice massage and bodywork therapy if an applicant has a criminal record or there is other evidence that indicates the applicant lacks good moral character.

The state of North Carolina as well as the Western North Carolina school of Massage have adopted into practice the NCBTMB Code of Ethics for working with massage therapy clients. This includes massages preformed at the school during a students clinical internship. See the attached code of ethics on the following page.

CODE OF ETHICS

Anyone using the designation Massage Therapist or is a student in a massage therapy program shall act in a manner that justifies public trust and confidence, enhances the reputation of the profession, and safeguards the interest of individual clients. Licensed Massage Therapists/Student Massage Therapists will:

- I. Have a sincere commitment to provide the highest quality of care to those who seek their professional services
- II. Represent their qualifications honestly, including education and professional affiliations, and provide only those services that they are qualified to perform;
- III. Accurately inform clients, other health care practitioners, and the public of the scope and limitations of their discipline;
- IV. Acknowledge the limitations of and contraindications for massage and bodywork and refer clients to appropriate health professionals;
- V. Provide treatment only where there is reasonable expectation that it will be advantageous to the client;
- VI. Consistently maintain and improve professional knowledge and competence, striving for professional excellence through regular assessment of personal and professional strengths and weaknesses and through continued education training;
- VII. Conduct their business and professional activities with honesty and integrity, and respect the inherent worth of all persons;
- VIII. Refuse to unjustly discriminate against clients and/or health professionals;
- IX. Safeguard the confidentiality of the client's identity and information in all conversations, advertisements, and any and all other matters unless disclosure of identifiable information is requested by the client in writing, is medically necessary or is required by law;
- X. Respect the client's right to treatment with informed and voluntary consent. The practitioner will obtain and record the informed consent of the client, or client's advocate, before providing treatment. This consent may be written or verbal;
- XI. Respect the client's right to refuse, modify or terminate treatment regardless of prior consent given;
- XII. Provide draping and treatment in a way that ensures the safety, comfort and privacy of the client;
- XIII. Exercise the right to refuse to treat any person or part of the body for just and reasonable cause:
- XIV. Refrain, under all circumstances, from participating in a sexual relationship or sexual conduct with the client, whether consensual or otherwise, from the beginning of the client/ therapist relationship and for a minimum of six (6) months after the termination of the client therapist relationship, unless an ongoing current sexual relationship existed prior to the date the therapeutic relationship began;
- XV. Avoid any interest, activity or influence which might be in conflict with the practitioner's obligation to act in the best interests of the client or the profession;
- XVI. Respect the client's boundaries with regard to privacy, disclosure, exposure, emotional expression, beliefs and the client's reasonable expectations of professional behavior. Practitioners will respect the client's autonomy;
- XVII. Refuse any gifts or benefits that are intended to influence a referral, decision or treatment, or that are purely for personal gain and not for the good of the client; and
- XVIII. Follow the NCBTMB Standards of Practice, this Code of Ethics, and all policies, procedures, guidelines, regulations, codes, and requirements promulgated by the National Certification Board for Therapeutic Massage & Bodywork, Inc.
